

Concealed Carry Weapon License Checklist

Initial Application, Phase One

- 1. Full-time resident of Santa Cruz County. Proof of residency to include the following:
 - a. California Driver's License OR current active military ID and original state ID
 - b. County certified birth certificate or naturalization papers/certificate
 - c. Current utility bill in your name with service address (must be gas, water electric or trash)
- 2. Complete Standard Application for License to Carry a Concealed Weapon (Cal DOJ form BOF4012). Initial every page of the document.
- 3. Proof of ownership and registration of each weapon to license for concealment (maximum of 3).
- 4. Complete Pre-Background Interview Form
- 5. Complete Employment and Residence History Form
- 6. Check payable to the County of Santa Cruz in the amount of \$94.97*
- 7. Complete Live Scan applicant fingerprinting for CCW application (DOJ fees paid by applicant)
- 8. Interview with Professional Standards and Conduct Sergeant

If approved applicant moved to phase two. If denied, the applicant will be notified in writing.

Phase Two

- 10. Two recent passport size photos (2" x 2") of the applicant.
- 11. If necessary, medical doctor review
- 12. Psychological examination
- 13. CCW qualification course (16 hours) with all handguns applied for with approved instructor

*As of 1/1/2023, the Carry Concealed Weapon (CCW) License fee is \$474.84. Twenty percent (20%) of the fee, \$94.97, must be paid when the application is submitted, this portion of the fee is non-refundable. At the conclusion of Phase Two, the applicant will be notified of the application outcome in writing. If approved, the applicant must pay the remaining CCW application fee balance, \$379.87, before the CCW license is issued.

Renewal Application, Phase One

- 1. Full-time resident of Santa Cruz County. Proof of residency to include
 - a. Current utility bill in your name with service address (must be gas, water, electric or trash)
- 2. Complete Standard Application for License to Carry a Concealed Weapon (Cal DOJ form BOF4012). Initial every page of the document.
- 3. Three signed letters of character reference from individuals other than relatives.
- 4. Proof of ownership and registration of each weapon to license for concealment.

- 5. Complete Live Scan applicant fingerprinting for CCW application (DOJ fees paid by applicant)
- 6. Interview with Professional Standards and Conduct Sergeant

If approved applicant moved to phase two. If denied, the applicant will be notified in writing.

Phase Two

- 6. Two recent passport size photos (2" x 2") of the applicant.
- 7. If necessary, medical doctor review
- 8. If necessary, psychological examination
- 9. CCW qualification course (8 hours) with all handguns applied for with approved instructor
- 10. Pay \$52 to CA DOJ (Bureau of Firearms FLPS, PO Box 160367, Sacramento, CA 95816-0367)

If approved or denied at the conclusion of phase two, the applicant will be notified in writing. If approved, \$25 dollar processing fee (cash or check) made out to the County of Santa Cruz. A \$10 fee will be charged for modifications to a CCW license.
