## Media Release: January 31st, 2025 Unmanned Aerial System Annual Report

As part of our commitment to the community, we are releasing this annual report regarding the usage of the Santa Cruz County Sheriff's Office Unmanned Aerial System (UAS) Team.

The UAS Team consists of 16 members of the Sheriff's Office who are certified under Code of Federal Regulations Title 14 part 107 to fly drones in a commercial capacity.

In 2024 the UAS was deployed 66 times. Those deployments included search and rescue operations, suspect searches, crime scene documentation, storm damage surveys, high risk incidents and search warrant services.
