### Media Release: January 16TH, 2026 Unmanned Aerial System Annual Report

As part of our commitment to the community, we are releasing this annual report regarding the usage of the Santa Cruz County Sheriff's Office Unmanned Aerial System (UAS) Team.

The UAS Team consists of 14 members of the Sheriff's Office who are certified under Code of Federal Regulations Title 14 part 107 to fly drones in a professional capacity.

In 2025 the UAS was deployed 52 times. Those deployments included search and rescue operations, suspect searches, crime scene documentation, water rescues, high risk incidents and search warrant services.
